Omega 3

Food supplement



Omega 3 contains high-quality omega-3 fatty acids docosahexaenoic acid (DHA) and eicosapentaenoic acid (EPA) from the Peruvian anchoveta, as well as an antioxidant - vitamin E.

EPA and DHA support normal heart function and are important for maintaining normal triglyceride levels in the blood. Omega-3 fatty acids are important precursors for the formation of eicosanoids (hormone-like substances) and are present in the human body, especially in the brain. EPA and DHA can be produced in the body from the fatty acid alpha linolenic acid found in certain vegetable oils, but mostly in insufficient quantities. In addition, their synthesis can be inhibited by the usually too high proportion of omega-6 fatty acids in the diet.

Chondroitin and glucosamine are important components of cartilage, connective tissue and synovial fluid. Hyaluronic acid is also found in cartilage and joints and functions as "joint lubricant". MSM is an organic sulphur compound found in plant and animal foods, but it can also be synthesised within the body's own sulphur metabolism from dimethylsulfoxide (DMSO). 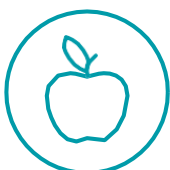

L-lysine

Food supplement



L-lysine contains the essential, basic amino acid L-lysine, which can be used as a supplement in various situations.

The human body cannot produce L-lysine itself, so it must be supplied with food. L-lysine is found in particular in animal foods such as eggs, milk and fish. Together with glycine and proline, L-lysine acts as an important building block in the biosynthesis of collagen. As the most essential fiber component, it is found in collagen, blood vessels, bones, teeth, tendons, as well as in the hair and skin. Especially in recurrent herpes infections, L-lysine can not only support wound healing, but also inhibit arginine-rich proteins, which could play a role in the replication of viruses. Certain situations such as growth, physical exertion, weakened immune system and advancing age can increase the need for L-lysine.
